## **Abstract**

The research aims at explaining the nature of the relationship between privatization and unemployment in some developing economies through the general indications of that relationship and its effect on unemployment for the period of the study(1990-2005).

Which is represented by:

- 1-The Gross domestic production.
- 2-The Government expenditure.
- 3-The Direct foreign investment.

And the application of these variables in econometrics practical model in the Chosen countries to know the effect of the economic relationship between the independence variables and the unemployment dependence variable for the mentioned period. The study included the hypothesis that the relationship between privatization and unemployment is not inverse in the short run and inverted in the long run through the effect of the variables that govern the effectiveness of programs for reforming economy in the long run.
