


OFFICE 365 VS G SUITE

How G Suite and Office 365 fare against each other in the key areas of pricing, features and ease-of use. Let's start by taking a look at what these products actually let you do.

Benefits

Office 365 and G Suite are a suite of productivity tools that let you perform common business tasks 'in the cloud'. Up until recently, G Suite was called Google Apps for Work, and many users and prospective users still refer to the product suite simply as Google Apps.

- Enterprise E3 - \$20 per user per month (requires annual commitment)
- Enterprise E5 - \$35 per user per month (requires annual commitment).

Practical Examples

Word processing: Microsoft
Office Word vs. Google Docs

Google Docs takes a minimalist approach to word processing by providing a simple document creator, unlike Microsoft Word which enables heavy-duty document creation.

As mentioned, Microsoft's flagship Word desktop processor is feature-rich and able to do a massive range of things, that Google Docs can't. However, for some, a lot of the features offered by Microsoft will go unused and are not necessary. In fact, sometimes Word can seem over-complicated and bloated with features.

Spreadsheets: Microsoft Office
Excel vs. Google Sheets

Microsoft's Excel is superior to Google's offering when it comes to spreadsheet tools. It is made for complex number crunching and sizeable data imports and exports.

This isn't to say that Google Sheet's is a total write-off. While Sheets won't be able to handle to sheer amount of data that Excel will, it does still offer good functionality, providing only light tasks are being performed.

PowerPoint vs. Google Slides

PowerPoint Online is arguably not as feature rich as Google Slides, making the former more easily usable. Besides, many users are more likely to have a Google account rather than a Microsoft account nowadays, making it more likely that free users will opt for using Google Slides more readily, even if it is just to upload and view a PowerPoint file.

Other Comparisons

Office 365 comes with 1TB OneDrive storage per user. Like Google Drive, OneDrive is a place for users can create, edit, download, and share documents and other media.

Google Security

When it comes to security, Google tries to have their users' best interest in mind. In fact, Google is not only HIPAA compliant but also certified with ISO 27001, ISO 27018, EY Point, and AICPA/SOC. These certifications highlight their dedication to security.

365 Security

Along with TLS and IPsec, Microsoft uses Advanced Threat Protection (ATP) to filter potentially dangerous email messages from company Office 365 inboxes (available on select plans). The protection keeps spam, viruses, and malware out without having to set additional settings.

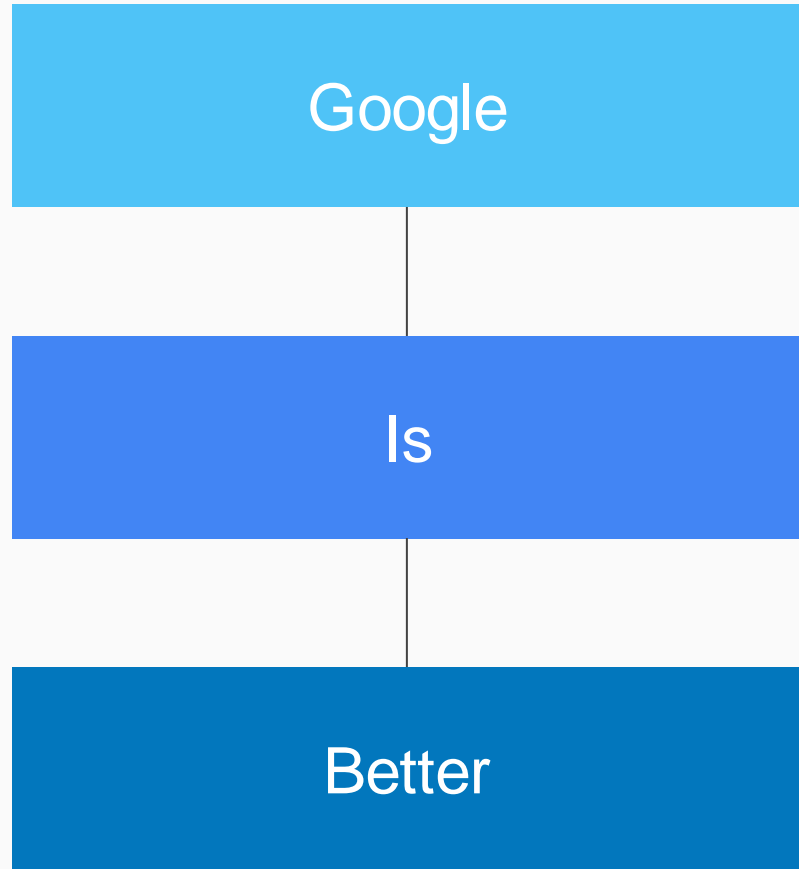
